# **HOW TO QUALIFY**

In order to qualify for the Tava Car Bonus Program bonus, you must meet the following requirements:

- · Be a Tava Distributor in good standing
- · Achieve Paid As Rank of Diamond for 2 consecutive months.

# TIME TO SHOP

Once you have met the Qualification Requirements, start looking for your new dream car! Refer to the list of approved makes, models, and color listed below to ensure you're getting a qualified vehicle.

#### **APPROVED CARS:**





Your vehicle must be no more than 2 years old and have less than 50,000 miles on it. It may be leased or purchased, and must be white in color.

# THE LOGO

The logo must be the approved Tava logo (submit design to Tava support) You may contact Tava support for approved logos.

# **BUY OR LEASE**

Before you get started, you must submit your car information for approval to Tava by email (<a href="mailto:support@tavalifestyle.com">support@tavalifestyle.com</a>). Fill in the form available by contacting <a href="mailto:support@tavalifestyle.com">support@tavalifestyle.com</a>).



# TIME TO EARN

You will earn up to \$2500 per month (See Chart below) toward the lease or purchase of a qualified luxury car.

Rank	Monthly Bonus
Diamond	\$1,000
<b>Double Diamond</b>	\$1,500
Triple Diamond	\$2,000
Crown Diamond	\$2,500

## **JUST MAINTAIN**

Just maintain Rank of Diamond and above to continue receiving the Car Bonus every month.

Any contract signed by the Tava Distributor is exclusively between said Distributor and your seller/dealer. Tava will not guarantee any purchase or lease payments and cannot offer any advice as to the Distributor's ability to finance said vehicle.

#### **BONUS PAYMENTS**

Tava Car Bonus - up to \$2500/month:

- Achieve the Paid-As Rank of Diamond or above (See Volume Requirements)
- · Maintain the Paid-As Rank of Diamond or above for 2 consecutive months.
- Provide completed Proof of Possession documentation
- · Maintain possession of a qualifying car
- Submit annual proof of Possession Renewal documentation
- Bonuses are paid as part of the Monthly Commission Cycle as follows:
  - Your first full bonus will be paid following the approval of your completed Proof of Possession documentation.
  - Subsequent bonuses will be paid upon maintaining the Paid Rank of Diamond or above.

Acceptance of a Tava Car in the form of an auto lease/purchase payment is not mandatory. There is no cash option (discounted or otherwise) available to the Tava Distributor.

## **EXISTING VEHICLE BONUS**

If you already lease or possess an eligible vehicle, you may participate in the TCB.

If you own outright an eligible vehicle, you may receive a monthly bonus of up to \$2500.

For both of these situations, you must apply via <a href="mailto:support@tavalifestyle.com">support@tavalifestyle.com</a> and provide Proof of Possession documentation.

## **IMPORTANT:** RESPONSIBILITIES & DOCUMENTATION

#### **CREDIT & FINANCIAL RESPONSIBILITY**

The decision to acquire a new or used vehicle is solely the responsibility of the Distributor in consultation with your dealer or lessor. Any contract signed by the Tava Distributor is exclusively between said Tava Distributor and your seller/dealer/ Tava will not guarantee any purchase or lease payments and cannot offer any advice as to the Distributor's ability to finance said vehicle.

Tava's obligation is to award your monthly bonuses to you based on program rules if and when you take delivery of your car and sign and return the attached signature page, fully executed.

#### **LEASE OR PURCHASE**

You have the to option to either purchase or lease.

- · There is no restriction on length of lease
- Purchasing your car will make you eligible for the monthly TCB provided you hit and maintain the rank of Diamond or above as outlined in this document, and provided you maintain ownership of the vehicle.
- Leases will make you eligible for the TCB only for the length of your lease. If your lease expires and you do not purchase your car or lease/ purchase another qualifying car, you will no longer be eligible for the Bonus.
- The vehicle must be leased/purchased in the same country where the Distributor is registered with Tava.

Tava will not offer advice to you regarding your ability to honor a lease contract or with respect to the terms of any lease. This agreement is strictly between you and the seller/lessor.

Any Tava Distributor that earns the Tava Car Bonus must have a valid driver's license, maintain all insurance required by law, and is responsible for all costs associated with the qualifying vehicle, including payments, fees, insurance, taxes, gasoline and maintenance.

## TRANSFERRING AND COMBINING OF BONUS

Bonus payments may not be transferred. In the event a family member or partner within the same household is a qualifier or acquires a qualifying car, he/she will receive the appropriate bonus payment after acknowledging receipt and understanding of these guidelines.

Combining of bonus payments towards a single vehicle is not permitted. Each qualified Diamond or above must acquire his/her own car to receive a bonus.

## INITIAL PROOF OF POSSESSION REQUIREMENTS

In order to receive your initial TCB the following is required:

- Completed Tava Car Bonus application submitted to <a href="mailto:support@tavalifestyle.com">support@tavalifestyle.com</a>
- · Clear and Legible Lease/Purchase Paperwork, including:
  - Your name or the name of your Co-Signer (see Co-Sign/Partner Agreement)
  - Year, Model, Color, VIN of your car
  - · Length/term of lease and end date

#### PROOF OF POSSESSION RENEWAL

Once per year, on the anniversary of your first bonus payment, you will be required to provide Tava, Proof of Possession of your car as outlined below.

#### What is required:

- Title or Deed in your name
- · Updated Registration in your name
- · Recent photograph of you with your car

Failing to complete the above, Tava Associaites may be subject to reimburse the company, distributorship termination, and any other sanctions per the Company's Policies and Procedures.

#### TERMINATION OF BONUSES

You will no longer be eligible to receive the Tava Car Bonus in the event of any of the following circumstances:

- You no longer own or lease the car that was acquired in accordance with the program
- You are no longer an active Tava Distributor or you sell your Tava Distributorship
- You fail to provide annual Proof of Possession documentation as outlined above
- You fail to maintain the Rank of Diamond or above (See Volume Requirements)
